Founded in 1970, the Child Care Council of Dutchess and Putnam, Inc., formerly the Dutchess County Child Development Council, Inc., is the New York State designated Child Care Resource and Referral Agency for Dutchess County. A private, 501 (C)(3), child care coordinating agency, CCCDP works closely with families, early childhood programs, employers, and elected officials to assess and meet the early care and education needs in Dutchess and Putnam Counties.

# CHILD CARE COUNCIL OF DUTCHESS AND PUTNAM, INC. Highlights of 2010

- The National Association of Child Care Resource & Referral Agencies (NACCRRA) Quality Assurance project officially began on February 1 with Peggy Paparone and Lorraine Scuccimarra as our Quality Assurance Coordinators.
- Our regional cluster (Dutchess/Putnam, Orange, Westchester, Rockland, Sullivan) investigated the feasibility of a regional call center.
- Oxclove Workshop developed and launched the Council's new website.
- The Council hosted a celebration of its 40<sup>th</sup> Anniversary and the Champions of Child Care. Howard Lynne chaired and emceed the event that drew a crowd of over 200.
- After 2 ½ years of work, the Crossroads Steering Committee, of which Jeanne Wagner was a member, presented the final statewide plan to Janice Molnar, Deputy Commissioner of the Division of Child Care Services, Office of Children and Family Services (OCFS). The plan included specific recommendations on: NACCRRA Quality Assurance, Referral Services, Innovative Pilots, Data management, Registration/ Licensing, Subsidy Management/Legally Exempt Enrollment, Shared Services for CCR&Rs, and Qualitystars New York. The presentation yielded no specific direction from Ms. Molnar.
- As a result of NACCRRA Quality Assurance requirements: 1) Staff formed committees to work on Resource & Referral, Marketing & Communication, and Training & Technical Assistance. 2) Board of Directors focused on tasks related to Governance – bylaws, numerous policies and procedures, and meeting format.
- The Dyson Foundation awarded the Child Care Council of Dutchess and Putnam, Inc. a \$75,000 grant to administer child care tuition scholarships to eligible families whose children attend day care centers in Dutchess County.
- Jeanne Wagner testified at City of Poughkeepsie Common Council meetings as to the importance of retaining child care openings in the City of Poughkeepsie, particularly Poughkeepsie Day Nursery, and of OCFS day care building regulations. The Common Council voted unanimously in favor of local historical designation of Poughkeepsie Day Nursery, allowing it to remain at its present location.
- Howard Lynne, Treasurer, presented the Council's Fund Development Plan to the Board and emphasized the requirement of the Board being members of the Child Care Council.
- Outreach & Marketing: The Council hosted a booth at Kids Expo and participated in Building Bridges Forum.
- The Council created the full time position of Training Coordinator. In that position, Rosemarie Dehn developed ten distance learning modules and presented numerous trainings at program sites, in addition to facilitating other trainings.
- The Council met or exceeded milestones and targets in the CCR&R and Registration contracts.
- The Child Care Council of Dutchess and Putnam, Inc. lost contracts in 2010:
  - Dutchess County Referral Service \$17,873
  - Dutchess County Increasing Child Care \$8,381
  - Ulster County School Age Child Care \$34,500
  - Dutchess County Early Intervention Program \$312,500
- This equated eventually to the loss of 8 jobs and additional decreased hours. However, with the support of the Board of Directors and dedication of staff the Council is a prime example of **doing more with less, and doing it well.**

The meeting was called to order at 3:35. The minutes from the June 2009 meeting were reviewed and Mr. Incoronato made a motion to accept the minutes and Ms. Haradon seconded the motion. The minutes from the May 26 Board meeting were reviewed and Ms. Zaccarra made a motion to accept the minutes and Ms. Bolner seconded the motion.

Board members introduced themselves as there were new members in attendance. It was announced that Ms. King will be leaving the Board as her term has ended. She was thanked for her contributions to the Board.

#### **Financial Committee:**

#### Howard Lynne

Mr. Lynn reviewed a draft of the balance sheet. The audit has just been completed. Mr. Lynne explained the difference in assets which was accounted for in the money spent on advertising. Some of the assets are stocks that were sold. Under liability assets, the accounts payable was higher as this was money to be paid for the Food Program.

Ms. Palmeri will be at the meeting in September to present the audit.

#### **Executive Director's Annual Report for 2010:**

#### Jeanne Wagner

Ms. Wagner reviewed some of the highlights for the year. The Council continues to have a positive work environment with low staff turnover. One staff member recently retired after 20 years of employment.

Ms. Wagner submitted to the Dyson Foundation and received funds for scholarships for center based child care. An award of \$75,000.00 was granted. This funding will be used to assist parents in the 200 - 250% poverty guidelines and selection will be done by lottery. Letters will go out to centers regarding the scholarships next week. The centers will be able to copy the flyer to give to parents. Ms. Wagner and Ms. Cirillo will administer the program.

#### Votes:

Ms. Haradon stated that a vote was necessary to renew the members of the Executive Board. The officers are as follows: Chair- Diane Labenski, Secretary – Linda Monkman, Treasurer, Howard Lynne, Member at Large - Linda MacIsaac, Member at Large, Past Chair – Deborah Haradon. Mr. Lynne made a motion to accept and Ms. Caddell seconded the motion. This was approved unanimously.

Mr. Lynne spoke on the importance of Board members becoming members of the Child Care Council. The by-laws state that Board members must be members of the Council. Mr. Lynne displayed the new Membership pamphlet to everyone. Mr. Lynne urged Board members to become members of the Council before September.

The 2009/2010 Board of Directors Orientation was distributed to members. The Council now has a Facebook page. Ms. Labenski asked members to share their ideas about how the Council can increase their visibility. There were suggestions to outreach to local churches and pediatricians. Ms. Albers said she will reach out to local real estate offices.

Ms. Labenski will send out the Committee Lists for members to sign up. The next Board meeting will be held on Sept. 22.

Mr. Incoronato made a motion to adjourn the meeting and Ms. MacIsaac seconded the motion.

The meeting was adjourned at 4:30.
