To help parents successfully find quality child care, the Council has provided a **printable checklist** below. Use this as a helpful tool, but do not discount your own intuition. If something does not seem right, continue to weigh your options.

Refer to the table below. This will assist you with descriptions of the modalities of care, definitions of each and ratio sizes.

According to New York State Social Service 390, a program must be registered/licensed where care is provided for more than 3 children for more than 3 hours. Your local Child Care Resource & Referral (CCR&R) agency is also available to answer any questions you may have regarding registered/licensed programs.

Be sure to also visit the NYS Office of Children and Family Services website for information about the NYS regulations and the compliance history of registered/licensed programs.
